

Seasons by the Sea Bistro Island Spa Getaway in PEI ("The Contest") OFFICIAL CONTEST RULES

1. TO ENTER: The Contest is open to residents of any Canadian province (excluding Quebec) aged 19 and over. Contest is not open to residents of Quebec.
